# Understanding and Mitigating Health Disparities Experienced by People with Disabilities Caused by Ableism

Research on the underlying mechanisms by which ableism adversely influences the health of persons with disabilities, as well as developing and/or testing interventions at a community or health systems level to mitigate adverse health effects of ableism are high priority.

#### Rare Diseases Clinical Research Network (RDCRN)

The RDCNR's mission is to advance medical research on rare diseases by providing support for **clinical studies** and facilitating **collaboration**, **enrollment and data sharing**. Through the RDCRN consortia, physician scientists and their multidisciplinary teams work together with patient advocacy groups to study nearly **200 rare diseases** at sites across the nation.

### Discrimination on the Basis of Disability in Health and Human Service Programs or Activities

The Department of Health and Human Services (HHS) has published a **proposed rule** that would update and amend its **section 504 regulations**, adding new provisions that clarify existing requirements under section 504 **prohibiting recipients of financial assistance from the Department from discriminating on the basis of disability** in their programs and activities.

Specifically, the past relevant work period would be reduced from 15 to 5 years.
