### **Medicare Overview**

- Established in 1965 to provide health insurance mostly to people 65+
- Some beneficiaries are<65 and permanently disabled (about 16%)
- Covers about 45 million people

 Part A – hospital, Part B – outpatient, Part C – Medicare Advantage (supplementary private insurance), Part D – prescription drug benefit





### **Medicaid Overview**

- Also established in 1965
- Provides health and long-term care (LTC) coverage
- Serves about 59M adults and children
- Beneficiaries are eligible individuals and families with low incomes and resources
- Augments Medicare for about 8M people
- Is a Federal-State partnership



# Children's Health Insurance Program Overview

- Enacted ten years ago as part of the Balanced Budget Act
- A child whose income is too high and is not eligible for Medicaid may be eligible for CHIP, an optional allotment program with fixed funding
- 29M children in Medicaid, 7 M in CHIP

- Generally States receive slight more Federal dollars to implement CHIP programs
- Income is usually at or above 200% of the Federal Poverty Level
- Some States use Medicaid to implement CHIP, or separate programs, or both



## CMS and the Interagency Autism Coordinating Committee (IACC)

- Is a member of the IACC
- Co-chairs the IACC Services Subcommittee
- Is a member of the Strategic Planning Subcommittee
- Provides technical assistance to States and other stakeholders interested in ASD services & supports
- Monitors programs that serve, or seek to serve, people with ASD
