




- The IACC updated the 2009 Plan to highlight the most pressing research needs and opportunities for the field today.
- The Plan, which must be annually updated in accordance with the Combating Autism Act (CAA) of 2006, provides a blueprint for autism research that is advisory to the DHHS and serves as a basis for partnerships with other agencies and private organizations involved in autism research and services.
- In the process of developing the 2010 update of the Plan, the committee collected feedback from scientists, advocacy groups, research funding organizations, and members of the public to guide their efforts to refine the first version released in 2009.




IACC INTERAGENCY AUTISM 2009 Summary of Advances



- The IACC identified 20 peerreviewed articles published in 2009 that they felt reflected the most significant advances in ASD biomedical and services research.
- These studies gave important new insight into the prevalence of autism spectrum disorder, the biology of the disorder, potential risk factors, and possible interventions.



ACC 2008 ASD Research Portfolio **Analysis**



- Federal agencies and private organizations provided information about the ASD-related research grants they supported in 2008.
- Report includes annual budget for each project and its relevance to the six questions of the 2009 IACC Strategic Plan for ASD Research:
- When Should I Be Concerned?
- How Can I Understand What Is Happening?
- What Caused This To Happen and Can It Be Prevented?
- Which Treatments and Interventions Will Help?
- Where Can I Turn For Services?
- What Does the Future Hold?
