Overview and Discussion of Process to Update the Strategic Plan

Subcommittee Charge Statement

The Services Research and Policy Subcommittee of the Interagency Autism Coordinating Committee (IACC) will assist the IACC with its responsibility to provide advice to the Secretary of HHS on changing needs related to research and policy about the organization, financing and delivery of services for individuals with autism. These services include but are not limited to those that address identification and treatment needs, housing, employment, safety, and social inclusion. The Subcommittee's immediate task will be the update of the Research Strategic Plan. By Dec 1, 2012, the Subcommittee will provide to the full IACC a draft update of the sections entitled "What do we know?" and "What do we need to know?" for Chapters 5 and 6 of the 2011 version of the Plan. For the purposes of the Research Strategic Plan, the subcommittee will address what is known and needed in the area of services research. In addition to this initial task, this subcommittee will support IACC roles and responsibilities related to services research and policy, including assistance with the annual update of the Research Strategic Plan beyond 2012.

Strategic Plan Update Process

- To facilitate the Update process, the subject matter of Questions 5 and 6 will be divided into broad topic areas
- In each topic area, external experts will work with a subcommittee member to produce a draft Update to share at the Workshop
 - Updates due to subcommittee co-chairs by October 15
- During the workshop, break-out groups will discuss the drafts and then report back to the full group with feedback and recommendations

Deliverables

- Bulleted draft due to subcommittee co-chairs by Monday, October 15th
- Updates due to OARC by Monday, October 22nd
- Present and discuss Updates at Strategic Planning Workshop on October 29th
- Incorporate feedback and finalize Updates for the 2012 Strategic Plan for ASD Research to be submitted to Congress by December 2012

Strategic Plan Update Process

- For each topic, address the questions “What do we know?” and “What do we need?”
 - Focus on the past 18 months (since the release of the 2011 Strategic Plan in January 2011)
 - Include funded and unfunded gaps
 - Use the 2010 IACC Portfolio Analysis Report and the 2011 Summary of Advances in ASD Research to help answer these questions
 - Approximately 2-4 pages total for each Update

Topic Areas

- Access and coverage
 - Including transition to adulthood
- Quality of care
 - Coordination of care
 - Implementation
- Education / Workforce
- Family support
- Comparative effectiveness and patient centered outcomes research

All experts will be asked to address these topic areas as they relate to both children and adults. Each expert will also address the knowledge gained and remaining research needs regarding racial, ethnic, socio-economic and geographic/residence disparities within each topic area.

- Pages 47-50 and 54-57 in the pdf document

For each question, address (in general):

- What are new key findings or discoveries from the past 18 months, and why are they important?
- What have we learned from the 2011 Summary of Advances and the 2010 Portfolio Analysis?
- Newly funded research that addresses gap areas
- What gap areas remain and how might they be addressed?
- What are the needs of the community?
