## **Email Campaign 2**

I am writing to urge you to demand that the FDA ban the use of the graduated electronic decelerator (GED) on individuals with disabilities.

The GED is a device that delivers a powerful and painful shock to wearers. The GED has been condemned by the United Nations as a weapon of torture against particularly vulnerable populations. The severely painful device is primarily used at the Judge Rotenberg Center (JRC) on autistic individuals who behave in ways that are deemed inappropriate by staff at the center. Behaviors that the JRC has used GED shock to discipline include but are not limited to: hand-flapping, standing, making noise, and screaming in pain from the administered shock. The GED has been known to burn skin and is traumatic for individuals exposed to the device.

Last year, the FDA successfully implemented regulations that banned the use of the GED on individuals with disabilities with the support of over 300,000 caring individuals. However, the JRC successfully lifted the ban in a lawsuit against the FDA. The unfortunate success of the lawsuit occurred because the FDA solely banned the use of the GED for behavior modification purposes. The court ruled that the FDA did not have authority to implement the regulation because the FDA did not completely ban the device overall.

I am therefore calling on you to support autistic individuals and people with cognitive disabilities by encouraging the FDA to produce a total ban against the GED. Your support is necessary to protect the well-being of vulnerable individuals residing in the JRC and susceptible to grueling abuse.

Urge the legislature to cut the funding of the Judge Rotenberg Center.

**Please include an amendment in the Keeping All Students Safe Act (KASSA) that would expand the bill's prohibitions to include aversive interventions and pass this Act.**

### **Email Campaign 3**

["As a Massachusetts resident, I support Bill H.225, which if passed, will prevent the use of aversives, including the GED device, on disabled students."]

**I would also like you to push for an outright ban on the Graduated Electronic Decelerator (GED) device. Please include an amendment in the Keeping All Students Safe Act (KASSA) that would expand the bill's prohibitions to include aversive interventions and pass this Act.** The FDA previously banned the use of this device only in relation to behavior modification, which has just been overturned by the D.C. Circuit Court. The GED devices (GED-1, GED-3a, and GED-4) need to be outright banned as they serve no purpose other than to provide pain and therefore torture to the person receiving it.

The Judge Rotenberg Center tortures autistic people, people with intellectual disabilities, and people with mental illnesses with this shock device. They currently use the GED-3a and GED-4 devices. This GED-4 device gives out up to 90 mA current, nearly up to 3 times over the maximum current limit of the FDA. The GED-3a and GED-4 devices **are not approved by the FDA and never have been.**

The GED devices accidentally discharge, staff accidentally shock the wrong student, and the students are forced to wear these devices 24/7, including while bathing or showering, which has caused 2nd-degree burns due to malfunctioning in water.

The GED is abusive. Shocking autistic people and people with intellectual disabilities for not taking their coat off fast enough is abusive. This device should not be considered a medical device or a "treatment" in any way. This device is torture.

Please push the FDA to ban the GED device outright, and to prevent the restraint and abuse of all autistic people and people with intellectual disabilities in the US.

Here is a quote from Jennifer Msumba who went to the Judge Rotenberg Center describing the electric shocks that she endured: "It lasts 2 seconds but it feels like 10-15 seconds. The feeling is like this pulsing, pulling, yanking, burning sensation that they get in your arm, leg, whatever spot they shock you in. It doesn't go through your whole body. It will just stay on that one spot where they shock you, but it will tear into it and your whole muscles will clench up and raise up, and you have no control over your muscle for that period of time. It's a terrible pain. I have no idea how to describe it. They describe it as a bee sting, but some people will say it's like a hundred bee stings, it's not just like a little bee sting, it's like a bunch of bee stings. Unless you've been tasered or something, or electrocuted by something, I

As a Chair in Developmental Psychology at University of Edinburgh I am appalled by observing that this evil behaviour is being permitted in a country that the entire world looks to as an example.

## **Algernon Lutwak**

I'm writing to request that you recommend legislation regulating the use of aversives, particularly GEDs, starvation, physical restraint, and forced sensory stimulation, in the treatment of autistic patients. The recent JRC v FDA ruling represents an appalling miscarriage of justice, and it frightens me that I as an autistic person escaped violence and torture there through sheer luck.

While the research on ABA's efficacy, as shown by recent systemic review articles, is mixed, the question of its longterm psychological effects on victims, even in the absence of aversives, is less ambiguous. Its underlying principles, particularly behaviorism, have been more broadly disproven in psychology circles: only autistics are still considered inhuman enough to merit such "treatment."

I appreciate that it's the entrenched "gold standard" of autism treatment, and that that cannot be immediately altered. However, given that JRC representatives spoke at last year's ABAI conference and that no national ABA-based group has spoken out against the recent ruling, it's clear that greater regulation of violent and potentially lethal aversives in ABA therapy is called for.

Please show that you value our lives. Recommend passage of the Keeping All Students Safe Act with specific provisions regarding aversives and GED. Take whatever other measures lie within your power to promote autistic safety from those who would "treat" us with violence.

I am writing to condemn the July 6th 2021 overturning of an FDA regulation that would have banned use of the Graduated Electronic Decelerator (GED). These devices deliver extremely painful shocks. The children who have to wear them because it's supposed to modify their behavior suffer additional pain beyond the shocks intentionally set on them by also getting shocked sometimes by mistake and getting burns because they have to wear them 24/7 even in the shower when water damages the device. They are used by the Judge Rotenberg Educational Center in Massachusetts whose students are mostly of color adding to the facts of abusing children that there is not only disability injustice but also racial justice.

We don't even use collars like these on criminals and yet this torture is doled out to children who are struggling against the very way their brain is wired and even behaving sometimes the way neurotypical children do like not being able to sit still. In one case, a teenage student was shocked 31 times for not wanting to take his coat off.

Furthermore, there is no evidence that this "treatment" actually works to modify the students' behavior. Quite the contrary, children who suffer this barbaric practice are more likely to develop PTSD, further destabilizing their ability to regulate their emotions and behavior.

## **Noud Rooijackers**

About 8 days ago, the use of GED's, devices used to deliver very powerful electric shocks, has been made legal in Massachusetts to be used at the Judge Rotenberg Center on autistic people and people with developmental, emotional or other mental disabilities. Many of the people this device is used on, are children. The GED has already caused the deaths of some students at the JRC. There have been 6 reported deaths at the JRC, most of which are a direct result from electric shocks being delivered to their bodies. There is also estimated to be even more deaths that the JRC tried to cover up. The GED's shocks are so strong that if they don't kill the person who is on the receiving end of these shocks, can get third degree burns on their body, and the trauma it brings with it is no joke either. The JRC will claim they barely ever shock their students but survivors from the JRC tell a whole different story. And the reasons they shock their students are also absurd. People have been reported to receive shocks for not taking off their coats, wrapping their feet around the leg of a chair, swearing, flapping their hands, and much more. Often, the JRC doesn't even tell the students why they were being shocked, which defeats the whole point of the shocks, since the shocks are supposed to teach the student something. But how can they learn to do or not to do something if they're not being told what they were being punished for? This is straight up torture. I, and many others, would really appreciate it if something could be done about this, primarily getting the GED's banned would be a huge step in the right direction. Please don't allow this to continue any longer. Thanks in advance.

The Judge Rotenberg Center has engaged in abusive practices since its founding, including severely restricting calories as punishment, painful sensory exposure, and excessive use of restraints. Physically beating and pinching residents more or less ended with the development of the Graduated Electronic Decelerator - a full-body shock harness that can deliver enough electrical current to cause burns. People have died at this facility as a result of repeated electrical shocks, sometimes delivered while the subject was in restraints (and therefore incapable of harming self or others).

We have reached a point in autism research where we know, definitively, that these kinds of aversive therapies do nothing to help the people subjected to them, and instead cause further trauma. If this "therapy" genuinely saves lives, where are the autistic voices praising it for saving them? Where are the voices of residents and former residents asking for the program to continue?

## **Meta B.**

Writing from outside the US, but I hope my experience can provide some insight to think about.

As an autistic adult myself, I've spent a large part of my childhood growing up in institutions for autistic children.

And in my own experience, it haven't been a good place growing up.

Being a very shy kid, I would only use spoken language around my parents, and not in school or institution due to lack of confidence and trust.

Starting from my early teen years:

Because of the, back then, lack of understanding of autism from both my parents side, as well as from "autism experts" and teachers and caretakers, and the lack of good resources that goes with that, my parents couldn't help me when I told them time and time again that I was very unhappy in my current school. Because I was already going in a special school for autistic kids. But I was the only kid there who couldn't communicate or take care of my own needs, among my other classmates who could do that just fine. And the teachers just didn't know how to treat me in a respectful way, and help me grow in a way that suited me.

The same story repeated when I started to grow very unhappy with my institution during my mid teen years.

Up until my very late teens, I could voice my opinion, but my words were not taken serious. I simply did not get to have a say in any final decisions others made over important aspects of my life. That life never felt like it belonged to me.

People simply didn't know the importance in consulting me about my own life.

Our own government just couldn't help us, and once suggested my parents to put me in a youth prison for young men, out of sheer ignorance for what autism is even about.

Needless to say, my parents declined that offer right away.

Over the course of my mid to late teens, things started to escalated for the worse, but what finally changed my life for the better was both the understanding and compassion from my parents, as well as the flexibility of alternative resources to suit my needs better, when I was finally pulled out of the school system and the institution altogether, to live full time at my parents until they found me another place.

Two thing that contributed to this lack of regard for my well-being while growing up, is the lack of active involvement from actually autistic adults in the research field over our own lives.

We are often observed from an outside perspective, and are given very little opportunity to provide our own insights, in a field that we are really the true experts.

The other thing is not taking the words of children serious, when they say that something is not right, or they come forward to say they are in distress or being abused one way or another.

What we need is focus on creating resources that first and foremost focus on the needs and quality of life for all autistic people, and ensure we have the tools to learn and grow and live in ways that best suits us.

Resources that can be flexible. Resources that can suits us in different stages of our lives, and different levels of support needs.

**Fionnuala Larkin**

I am writing in the hope of giving support to the movement to ban the use of electric shocks in interventions for autistic individuals. I am a clinical psychologist experienced in the field of autism and intellectual disabilities, and an active researcher. I am well aware of arguments and justifications for using aversive techniques to reduce harmful behaviours in autism. However, taking psychological theory, research evidence, clinical experience and ethical considerations into account, it is absolutely clear that aversive techniques of this kind should not be in practice anymore. While fear and pain can bring about compliance, this is at the expense of the safe, therapeutic spaces that all individuals need in order to develop and grow. Silence is not the same as tranquility: an individual may be shocked into submission without learning or developing in any meaningful way, and the process will be detrimental to their ability to develop the safe, trusting relationships that can be therapeutic. Contemporary thinking in supporting individuals with challenging behaviours emphasises the need to create safe, low-stimulation environments that are adapted to the sensory needs of the individual, with well-supported and supervised staff and caregivers. This is vital to protect the human rights of all the individuals we support. I would strongly urge that the ban on these devices be reinstated, and for schools and other institutions using these to be supported to develop more modern and humane approaches to supporting individuals with behaviours that challenge.

**Marie Triant, M.S. CCC-SLP**

My name is Marie Triant. I am a Speech-Language Pathologist working with children and adults between the ages of 2-23 years old in the North Shore area of Massachusetts. Many of these individuals with whom I work have autism diagnoses, intellectual disabilities, or developmental disorders.

I'm writing to ask you to support the Keeping All Students Safe Act (H.R.3474). This bill would ban restraint and seclusion, two life-threatening practices that disproportionately impact students with disabilities. Ending the use of restraint and seclusion would save lives, prevent abuse, and make our centers, clinics, and schools safer for the neurodivergent (having a neurologic diagnosis such as Autism, ADHD, Tourette's, etc.) and disabled populations.

Currently, graduated electronic decelerators (GEDs) are used in Massachusetts at the Judge Rotenberg Center (JRC) in Canton, MA, by staff implementing Applied Behavior Analysis (ABA). The volts on the devices used at the JRC have a maximum amperage of 90 mA, which is only 10 mA less than the potentially lethal amount (100 mA).

This practice is illegal for abled neurotypical (those without neurologic diagnoses) children and adults, as well as pets and zoo animals. However, it is legal for children and adults who have intellectual disabilities, developmental disabilities, and who are autistic.

In 2020, the FDA banned the graduated electronic decelerator (GED).[1][2] This is a device used to punish residents of the Judge Rotenberg Educational Center (JRC) in Canton, Massachusetts, many of whom are autistic, with extremely painful electric shocks in an attempt to control their behavior.[3][4] Earlier this month, the D.C. Circuit Court of Appeals overturned the ban.[5][6] Please do all you can to end this practice and to protect people, including autistic people, from being punished with electric shocks.

The GED is torture; its use constitutes a violation of international standards including the U.N. Convention against Torture, according to U.N. Special Rapporteur on torture Juan E. Méndez's official report.[7] It is often used together with punitive seclusion, restraint, and the withholding of food to the point of undernourishment.[4]

The JRC has sometimes claimed only to shock residents to stop self-injurious and aggressive behavior. That is inaccurate. Examples of behaviors retaliated against with electric shocks include taking off a coat and screaming in pain from being shocked.[8][9] Furthermore, this is torture, not treatment, and it would be unacceptable even if it were only used in response to dangerous behavior (which it is not). Expert consensus (including behaviorists) has long been that electric shock punishments are always harmful, ineffective, and unjustifiable; see [10] and 'Critique of aversive treatment from research and policy' (and references therein) in [4].

There has been some media focus on residents who have been repeatedly shocked by the GED in a single session.[11][12][13] The culture surrounding the GED is one of careless willingness to inflict terrible pain on helpless people; in one case, staff inflicted numerous shocks on a resident when instructed to do so by a prank caller.[14][15] The founder and former head of the JRC resigned pursuant to a criminal plea agreement, after destroying evidence of abuse.[16][17] But the abusive practices continue.

Some of the worst uses of the GED are routine and not the result of any accident. A number of former residents of the JRC who have been subjected to the GED have spoken out against its use. For example, this is a former resident's description of 'behavioral rehearsal lessons' (BRLs) when interviewed by Disability Rights International (see [4], p.18-19, which are the 28-29th pages of the PDF document, and references therein, which confirm this practice, including a report by the New York State Department of Education):

?The worst thing ever was the BRLs. They try and make you do a bad behavior and then they punish you. The first time I had a BRL, two guys came in the room and grabbed me ? I had no idea what was going on. They held a knife to my throat and I started to scream and I got shocked. I had BRL?s three times a week for stuff I didn't even do. It went on for about six months or more. I was in a constant state of paranoia and fear. I never knew if a door opened if I would get one. It was more stress than I could ever imagine. Horror.?

See also accounts by Jennifer Msumba of the extreme toll the GED took on her.[18][19][20] She was so anxious and terrified, on a constant basis.?[19] She was shocked for behaviors such as fidgeting and wiping cream cheese off a piano bench (because she was prohibited from 'manipulating objects').[20]

It is my hope that the experience and resourcefulness of the IACC will be brought to bear to protect everyone, including autistic people and people with other disabilities or mental illness, from ever being subjected to torturous electric-shock punishments. In the recent D.C. Circuit Court decision that overturned the FDA's ban on the GED, the court ruled not that the FDA's justification for the ban was in any way deficient, but rather that the FDA has the power to ban a device altogether but not to ban a device only for particular purposes.[21][22][23] The FDA had left open the possibility of someone voluntarily self-administering electric shocks with the GED or a similar device, for such purposes as smoking cessation. Given what is at stake, for the ban to be limited in that or any way is unnecessary, and the FDA can, and should, ban the GED completely. I urge the Committee to advise the FDA to pursue that course of action (as well as to challenge the ruling by petitioning for an en banc rehearing and/or appealing to the Supreme Court). But more broadly I ask that the Committee do all it can to stop the abusive and harmful practice of punishing people, including autistic people, with painful electric shocks.

I am writing to urge the IACC to condemn July 6<sup>th</sup>'s reversal of an FDA regulation that would have banned use of the Graduated Electronic Decelerator (GED) for use in behavior modification at the Judge Rotenberg Educational Center in Massachusetts. This device issues extremely painful skin shocks for the purposes of behavioral modification and has been named a device of torture by the United Nations. Importantly, the Judge Rotenberg Center houses students primarily disabled students of color from New York City, making the ban on the GED a pressing issue of disability and racial justice.

Urge the IACC to take steps to recommend the withdrawal of state and national funding of the Judge Rotenberg Center, specifically, and to condemn the use of harmful aversive tactics like the GED, and practices of seclusion and restraint in institutional settings. Moreover, I urge the IACC to vocally advocate for home and community care options that respond to disabled self-advocates' calls for supports that appropriately meet their needs.

These issues are personal to me and my community. My mother teaches developmentally disabled students, primarily students of color, in New York City's District 75 schools. Her students are those with high support needs and are precisely the kinds of students most vulnerable to the kinds of abuses perpetuated by facilities like the Judge Rotenberg Educational Center. In an increasingly cruel and overtaxed system, her work is to advocate for these students, to ensure that they are never subject to the kinds of physical and emotional trauma that come from the use of seclusion, restraint, and pain-inflicting devices like the GED. Disabled students must have their humanity recognized and their bodily autonomy respected. Anything short of that is a systemic failure to meet the needs of this vulnerable population.

**Jessica Hoffman**

The process of using electric shocks on disabled people at the JRC is nothing short of torture. Autistic people are not broken or in need of a cure; we are in need of support. Using tactics like this to force us into behaviors more pleasing to neurotypical people is not support. It is torture, plain and simple. This horrific "treatment" method should be immediately stopped and banned in any application, situation, circumstance, etc. There is absolutely no excuse for torturing disabled people, and allowing it to continue is a shameful violation of human rights.

## **Katie Harrell**

Please push for an outright ban on the Graduated Electronic Decelerator (GED) device. Please include an amendment in the Keeping All Students Safe Act (KASSA) that would expand the bill's prohibitions to include aversive interventions and pass this Act. The FDA previously banned the use of this device only in relation to behavior modification, which has just been overturned by the D.C. Circuit Court. The GED devices (GED-1, GED-3a, and GED-4) need to be outright banned as they serve no purpose other than to provide pain and therefore torture to the person receiving it.

The Judge Rotenberg Center tortures autistic people, people with intellectual disabilities, and people with mental illnesses with this shock device. They currently use the GED-3a and GED-4 devices. This GED-4 device gives out up to 90 mA current, nearly up to 3 times over the maximum current limit of the FDA. The GED-3a and GED-4 devices are not approved by the FDA and never have been.

The GED devices accidentally discharge, staff accidentally shock the wrong student, and the students are forced to wear these devices 24/7, including while bathing or showering, which has caused 2nd-degree burns due to malfunctioning in water.

The GED is abusive. Shocking autistic people and people with intellectual disabilities for not taking their coat off fast enough is abusive. This device should not be considered a medical device or a 'treatment' in any way. This device is torture.
