## **FEDERAL AGENCY UPDATES**

### **Administration for Community Living (ACL)**

- In September 2022, ACL awarded a cooperative agreement totaling an estimated \$3.25 million over five years to create a national technical assistance and resource center that will improve support for people with co-occurring intellectual and developmental disabilities and mental health needs so they can live and participate in their communities. - ACL awarded a grant to the Cincinnati University Center of Excellence in Developmental Disabilities, which will lead a coalition of national partners, including Morehouse School of Medicine, the National Cultural Competency Center, the Kennedy Krieger Institute, and the Autistic Self Advocacy Network, in a five-year project to create the National Center for Disability, Equity, and Intersectionality (the Center for DEI). The Center for DEI aims for greater equity for people with disabilities through disability-led initiatives targeting ableism and racism with an intersectional lens. The goal of the Center for DEI is to lead the nation's charge to identify and reduce life-limiting inequities in healthcare, community living, and justice for people with disabilities. - ACL recently awarded two grants totaling \$125 million to rapidly increase the number of older adults and people with disabilities who have received the updated COVID-19 vaccine and annual flu vaccine. These programs will distribute funding and leverage partnerships across the aging and disability networks to host community vaccine clinics, provide in-home vaccinations, provide transportation to vaccination sites, conduct outreach and education to older adults and disabled people, and more. - The National Institute on Disability, Independent Living, and Rehabilitation Research (NIDILRR) is funding a new project (Parents Taking Action eHealth Adaptation and Pilot for Latinx, Black, and Chinese Families of Young Children with Autism Spectrum Disorder) that will study the intersection of race and ethnicity with the experiences of families with young children with ASD. The goal of this project is to address the disparities facing underserved racial and ethnic minority families by adopting an innovative microlearning concept in delivering bite-sized parent training content. The objectives are to adapt three culturally tailored versions of Parents Taking Action for Black (in English), Latinx (in Spanish), and Chinese (in Simplified Chinese) into bite-sized online learning content and to evaluate the feasibility, acceptability, and preliminary

evidence of efficacy of the adapted intervention. The researchers published several manuscripts in 2022 for similar NIDILRR-funded work:

- A NIDILRR grantee at the University of Kansas has received funding through several of NIDILRR’s funding mechanisms over many years to build capacity among parents to provide interventions for their children with ASD. This year, they received new funding for one project to further these efforts. The overall goal of this project is to fully develop and test the Online and Applied System for Intervention Skills - Supervision (OASIS-S), an online platform designed to build professional capacity for individuals pursuing the Board-Certified Behavior Analyst (BCBA) credential to primarily to serve individuals impacted by autism spectrum disorders (ASD). During this phase, this project develops and integrates a within-system video review feature to ensure HIPAA/FERPA compliance, expands the content to match the current professional supervision requirements, and fully develops/deploys the supervision hours tracking feature.
- NIDILRR began funding two other new Small Business Innovation Research Projects in 2022. These include:

### **Centers for Disease Control and Prevention (CDC)**

- CDC has awarded funding for the sixth funding cycle of the Autism and Developmental Disabilities Monitoring (ADDM) Network and is beginning surveillance activities in January with new and returning sites. The 11 ADDM Network sites will track early identification, prevalence, and characteristics of children with ASD among 4- and 8-year-olds; a subset of the sites (five) will also track co-occurring conditions and educational transition planning among 16-year-old adolescents. - Planning is also underway for the additional \$5 million in funding for the ADDM Network in the recently passed budget to expand ASD tracking activities and re-establish cerebral palsy surveillance in at least two sites.
- ASD prevalence and early identification findings for 2020 from the ADDM Network are expected to be published in Spring 2023.
- CDC’s “Learn the Signs. Act Early.” (LTSAE) program has released an updated Milestones in Action – a FREE, online library of photos and videos to reflect the revised English-language developmental milestones:

- The LTSAE program continues working to collect images for its Spanish-language collection and expects to release them in the coming year.
- The English-language Milestone Tracker app will soon be updated with the new photos and videos. The app can be downloaded here:

- CDC’s Milestone Tracker app has been downloaded more than 1.5 million times. The LTSAE program has developed surveys for app users in order to learn what impact the app has on behaviors and outcomes related to early identification of developmental delay. The surveys might be launched by Fall 2023, pending approval.

### **Department of Defense (DOD)**

- The FY22 program cycle for the Autism Research Program (ARP) will be completing its two-tiered review process in the coming weeks. ## Social Security Administration (SSA)

- **Redesigned [www.SSA.gov](http://www.SSA.gov) Website**
  - In December 2022, the Social Security Administration has launched a redesigned website at [www.SSA.gov](http://www.SSA.gov). The reimagined website prioritizes customer experience. SSA.gov is visited by over 180 million people per year, and it is one of our most important tools for providing efficient and equitable access to service. Improved self-service capability allows people to skip calling or visiting an office, which helps Social Security staff focus on those visitors who need in-person assistance. Visitors to SSA.gov can use interactive tools to:
    - **Check eligibility for benefits:** The new benefit eligibility screener is a convenient and simple way for people to learn if they might be eligible for benefits.
    - **Save time on Social Security Number (SSN) and card online services:** To request a replacement card, request an SSN for the first time, or make

changes to your record, visit [www.ssa.gov/ssnumber/](http://www.ssa.gov/ssnumber/). Note that the Social Security Administration now offers people the choice to self-select their sex on their SSN record.

- **Start an application for Supplemental Security Income (SSI):** People can start the application process online and request an appointment to apply for SSI benefits by answering a few questions at [www.ssa.gov/benefits/ssi/](http://www.ssa.gov/benefits/ssi/)
- **Apply for Social Security benefits and other online services:** For most benefits, people can apply online or start an application online. In many cases, there are no forms to sign. The agency will review the application and reach out with questions or for more information. Visit [www.ssa.gov/onlineservices](http://www.ssa.gov/onlineservices) to apply for retirement, disability, or Medicare.
- Using a **my Social Security** account, a personalized online service, people can start or change direct deposit, or request a replacement SSA-1099. Individuals already receiving Social Security benefits can print or download a current Benefit Verification Letter if they need proof of their benefits. People not yet receiving benefits can use their online account to get a personalized Social Security Statement, which provides their earnings information as well as estimates of their future benefits. The portal also includes a retirement calculator and links to information about other online services. - **ICAP Round 2 Awards Announced**
  - On December 22, 2022, SSA made the second round of awards for the Interventional Cooperative Agreement Program (ICAP). Projects under ICAP are collaborative cooperative agreements with States, foundations, and other non-federal groups and organizations who have the interest and ability to identify, operate, and evaluate research related to the Disability Insurance and Supplemental Security Income programs. ICAP is an ongoing program that will accept new applications for award every year. This year, ICAP made awards to Mathematica and Westat for research that will include participants on the autism spectrum. Mathematica will conduct a randomized controlled trial to assess the impact of an employment intervention for youth with disabilities who are transitioning into the adult workforce. Westat will conduct a randomized controlled trial to assess the impact of combining supportive housing with Individual Placement and Support (IPS) supported employment services for recently homeless people experiencing a range of disabilities and mental health conditions. - **Upcoming Funding Opportunity – New competition for ARDRAW Grand Administrative Organization**
  - SSA is preparing to post the solicitation for a new grant administrator for the Analyzing Relationships between Disability, Rehabilitation, and Work (ARDRAW) Small Grant Program this quarter. ARDRAW consists of two parts: 1) a grant to an

organization to serve as grant administrator, and 2) subgrants to graduate students to perform research of interest to SSA's disability program. Graduate students who have previously been awarded ARDRAW subgrants have produced some excellent research relating to autism.

- **Eligible types of entities for the grant administrator role include:** research organizations; universities; associations of research organizations and universities; and University Centers for Excellence in Developmental Disabilities (UCEDDs); Leadership Education in Neurodevelopmental Disabilities (LEND) programs; Eunice Kennedy Shriver Intellectual and Developmental Disability Research Centers (IDDRCs); and similar programs. Only organizations in the United States are eligible to apply. - **Achieving a Better Life Experience (ABLE) Age Adjustment Act Signed**
  - Achieving a Better Life Experience (ABLE) accounts are tax-advantaged savings accounts that are available to certain people with disabilities. One advantage of an ABLE account is that the first \$100,000 in an ABLE account is exempted from the SSI individual resource limit.
  - The bipartisan ABLE Age Adjustment Act was signed into law in December 2022. This bill will raise the ABLE account qualifying age of onset of disability from 26 to 46 as of January 1, 2026, thus making an estimated six million more Americans eligible for an ABLE account.

### **Substance Abuse and Mental Health Services Administration (SAMHSA)**

- SAMHSA has issued an announcement seeking comments on standards for Certified Community Behavioral Health Clinics (CCBHCs). These are specially designated clinics that provide a comprehensive range of mental and substance use services. (See: <https://www.samhsa.gov/section-223> and <https://www.thenationalcouncil.org/program/ccbhc-success-center/ccbhc-overview/>). There are roughly 500 CCBHCs in 46 states. CCBHCs treat both adult and pediatric populations, and, as proposed, the draft certification criteria require that “[w]hen treating individuals with developmental or other cognitive disabilities, level of functioning is considered and appropriate evidence-based treatments are provided. These treatments are delivered by staff with specific training in treating the segment of the population being served.” Comments will be accepted through January 20, 2023, and instructions about how to comment are at this link: <https://www.samhsa.gov/certified-community-behavioral-health-clinics/ccbhc-criteria-update-announcements>

## **PUBLIC MEMBER UPDATES**

### **Autism Science Foundation (ASF)**

- ASF announced the recipients of our most recent pilot grant mechanism on January 10<sup>th</sup>, calling for ways to improve inclusion of individuals who are either minimally verbal or have extreme cognitive disability or both. They include a study on a new non-invasive way to detect brain activity during sleep, an understanding of who is using AAC devices and what sorts of training or support they use when they in fact access a device, an examination of self-injury in a large community-based setting across the state of Pennsylvania, and also an examination into the predictors and possible treatment of a phenomenon known as “neuropsychiatric regression”. This has been documented in the Phelan McDermid Syndrome community but in fact probably is not limited to that community. - We were also very happy to help organize a meeting of the Baby Siblings Research Consortium, held in early November 2022 in Minneapolis before it got too blistering cold. This is a group of 50 and growing scientists from around the world that are able to study families with autism as early as birth, and sometimes pregnancy, to understand not just the early origins of autism, but early detection and diagnosis. At this meeting we talked about both biological and behavioral signs of ASD that are present even before the diagnosis can be made, how to support families to improve outcomes of these siblings in a variety of ways and how to better communicate with health care providers so that accurate detection is possible across the community, not just experts in clinical psychology, and can help those across the spectrum.
- We are happy to announce our 10<sup>th</sup> Day of Learning will be on March 30<sup>th</sup> in NYC, again, hybrid. ### **Simons Foundation Autism Research Initiative (SFARI)**

- Sensory function, motor function, and sleep: SFARI is offering a new RFA in 2023 for cross-species research, with particular interest in these topics. The autistic community has highlighted the need for helpful interventions in these domains. - DEI in the community of autism scientists: SFARI continues to offer SEED grants (Supplement to Enhance Equity and Diversity), which provide up to \$100,000 per year

- Data from Autism Speaks MSSNG database was used in a recently published study in *Cell*. The team of researchers from The Hospital for Sick Children found 134 genes linked with autism, as well as various genetic changes, including copy number variations (CNVs) likely associated with autism.
