In each of the topical sections below, discuss:

- What are the key research advances that have helped us make progress in the field?
- Are there areas of where research is ready to be moved into practice?
- Are there opportunities for practice to inform research?
- Are there any barriers to research in this area that need to be addressed?
 - In several of the topical areas, the working group said that research progress that has been made on understanding the existing barriers, but more research needed on how to address barriers
- What are the most pressing scientific questions, gaps, opportunities, and needs in this area?
- What are the most pressing services needs today? Are there any emerging needs?
 - Workforce need that applies to multiple topics: Need for larger workforce to meet services needs; need more provider/practitioner training
 - Service Systems: Need for further efforts to help families navigate the service system; efforts to ensure each individual's services are coordinated, recognizing that individuals are in multiple service systems
 - Educational: Need for interventions to help keep children with disabilities in an instructional environment to maximize their potential
 - Lifelong Supports: Need for communication supports, among other types of lifelong supports
 - Is there new research evidence that can inform policy?
 - What are the near-term and long-term ways that some of these services implementation and policy issues can be addressed? Through research or through policy changes?

Topics for Overview of Progress in the field:

- 1. Healthcare/Insurance Coverage
 - Interventions
 - Primary care
 - Health and safety, outcomes
 - Quality of services
 - Co-occurring conditions and severe autism ensuring access to appropriate service
 - Coverage

- Changes in ACA implementation, Medicaid
- EPSDT as it relates to children receiving needed services (adult housing will be addressed in Q6)
- o Medical homes
- Billing rates and reimbursement preventing implementation of evidence based practices (this also may apply in other topic areas)
- Economics research
 - Could apply to multiple topic areas: More research is needed on economic outcomes and costs – need better data and better access to data to enable research
- Ensuring broad access
 - Innovative strategies to enable access, such as telehealth for providers and recipients of services
- 2. Education
 - Quality of interventions
 - Inclusion/participation
 - Outcomes
 - Distance learning
 - Multiple diagnoses
 - Implementation
 - In education and other service areas, there is a need for more research on how to support providers so they can successfully implement evidence-based practices
 - Also possibly applicable to several of the topic areas, there is a need to develop and build on current demonstration sites to provide infrastructure for implementation science and to determine how to best "scale up" successful models
- 3. Lifelong services and supports, including family supports
 - Communication supports
 - Caregiver supports
 - Outcomes and quality of services
 - Person centered planning and self-direction
- 4. Coordination of care across service systems
- 5. Disparities

- Underserved populations within the ASD community (ethnic, racial, cultural, gender, etc.)
- Recognition of disabled individuals as an underserved population in various services systems – some organizations are recognizing disabled individuals as underserved and in need of targeted strategies to reduce disparities in service access, etc.
